



**scope of work with terms and conditions:-**

**1. Architectural and Development Control drawing:**

- i. Preparation of sketch drawing, making changes as per the discussions and instruction of Vice Chairman, M D A or their nominee.
- ii. Preparation of detail drawing for Architectural of Traffic parks in detail Showing the elevation, section, height and external finishes.
- iii. Preparation of structural drawing of the Traffic parks with details required for the execution of the same along with the services drawings.

**2. Consultancy work for Traffic Theme Park at Location of Meerut to be constructed by M.D.A Meerut**

The Consulant Shall render the following services in connection with and regard to the said works.

- i. Taking the Employer`s making approx. Estimate of cost, area of measurement and preparing report of the scheme till sketch design & plan are finally approved by the Employer, based on the basic requirements,survey plans and information planned and provided by the authority.
- ii. Preparing detailed services drawings for internal water supply, sanitary installation and internal electrification of the same.
- iii. Perparing detail estimate separately for all Traffic parks work. water supply, structural and internal electrification work. This will be including specifications. detailed measurement bill of quantities of cost.
- iv. Provide necessary supervision and advice the employer as and when requested/by the employer during execution.

#### **4. Termination of Agreement**

- i. The Agreement herein may be terminated at any time by either party by giving a written notice of one month to the other party.
- ii. In case of termination the consultant shall be entitled for the fees payable to them for the work actually done.

#### **5. Transfer of Interests.**

The consultant shall not assign, sublet or transfer their interest in this agreement without the written consent of the Employer.

#### **6. Scale of Charge**

The employer shall pay to the Consultant as remuneration for the professional services to be rendered by them in relation to the work and in particular for the services here in before mentioned as follows:

#### **7. Consultancy Work for Traffic Park at various location of Meerut to be constructed by M.D.A. Meerut.**

For Services mentioned in 1.2 professional fees shall be as follows:

- i. The fees shall be payable as sanctioned by the Vice Chairman of M.D.A Meerut.
- ii. G.S.T. as applicable of the total fees vide item 4.1 above shall be charged over and above of the total charges.

#### **8. Cost of construction/Developmental Work:**

The total cost of development will be based on the final executed cost of all site development , civil, structural, electrical, sanitary, water supply work including site works relating to particular building, built in features, installation and equipment executed under the specific direction of the Architects. However till completion of construction, fee paid would be as per the tender documents.

#### **9. Mode of payment**

In the event of any dispute, difference the same shall be referred to for arbitration to the Vice Chairman of M.D.A Meerut and his decision on behalf shall be final and binding on the both parties.

## **13. Stamp Duty**

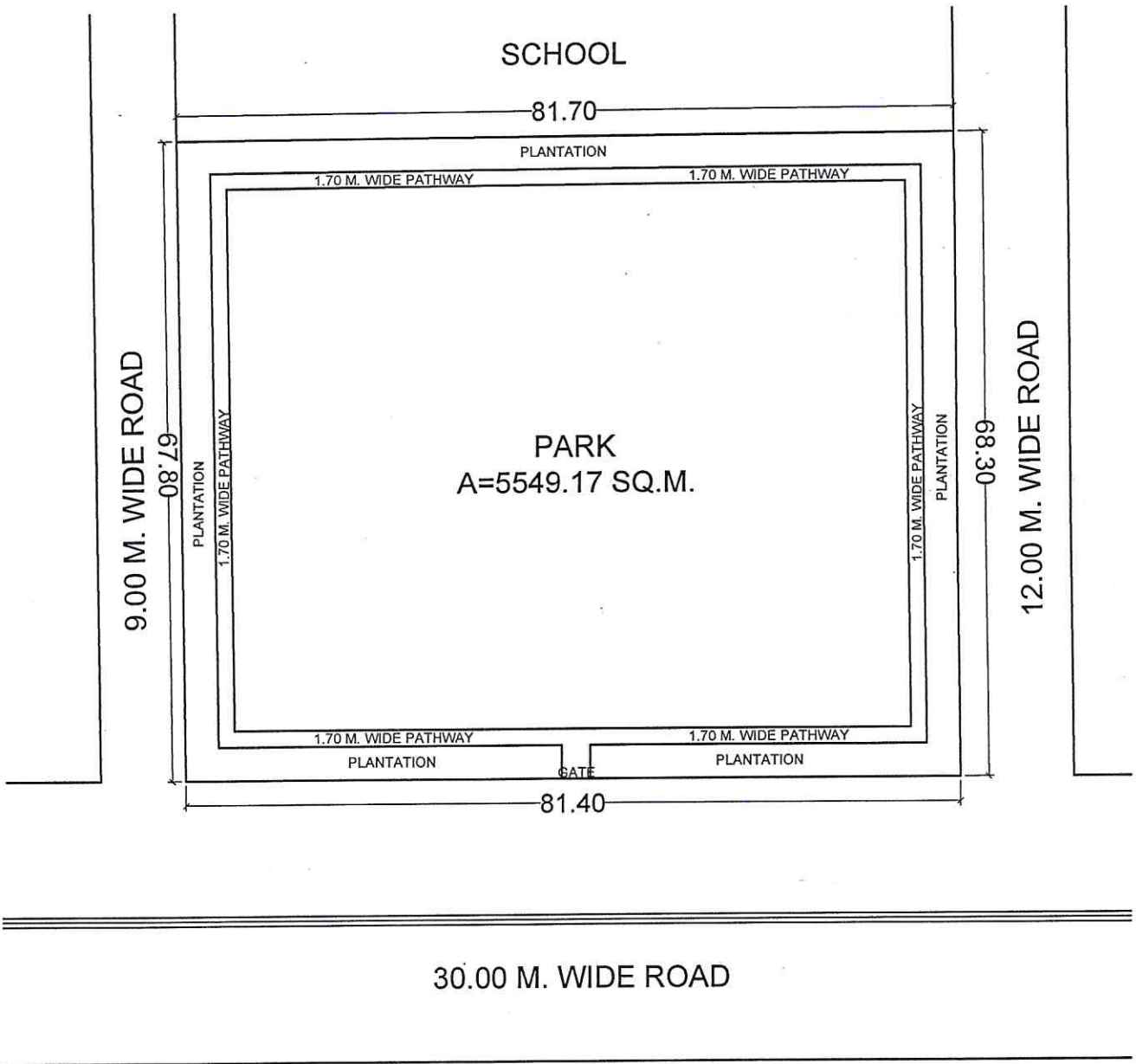
