CORRIGENDUM

Sub: Corrigendum to the RFP based on Queries raised by the bidders.

Ref: RFP document No-MeDA/24-25/EN/7039-1 Dated-11-02-2025 for Conceptualization, Design, Supply, Installation, Testing and Commissioning of Multimedia Light & Sound Show at Shyamal Dev Heritage Park, Meerut, Uttar Pradesh Including Comprehensive Operation & Maintenance for Five years

The corrigendum is issued to the following criteria:

The point no. 2 mentioned on Page no. 5 under the heading of "**Terms and Conditions**" in the RFP notice is removed as per this corrigendum.

The revised point no. 3 of Proof of Concept (POC) mentioned on Page no. 11 is read as "**The time allowed for carrying out the work will be 4 months and 5 years for Operation & comprehensive maintenance of the system after completion of project**".

The point no. 11 (a) & 11(b) of Proof of Concept (POC) mentioned on Page no. 12 & 13 respectively are removed as per this corrigendum.

The point no. 22 of Proof of Concept (POC) mentioned on Page no. 14 is removed as per this corrigendum.

The **Financial Capacity** mentioned under Clause 7.5.2 on Page no. 19 is revised and is read as "**The Average Annual Turnover of the Bidder for the last three financial years (2021-22, 2022-23 and 2023-24) should be minimum of Rs. 400.00 lakhs. If average annual turnover during last three years is less than 400 lakhs, the bidder will not be eligible**".

7. Clause 8.2 mentioned on Page no. 21 is revised and read as "**Payments for Operation and Maintenance for Five years (O & M) will be done on quarterly basis. The payments shall be released in INR only**".
