**Terms & Conditions** 

1. The cost of Bid document, E-Tender processing fee and Earnest Money Deposit (EMD) is required to be deposited through HDFC BANK LINK <a href="https://mdameerut.procure247.com/tenderPay/x-login">https://mdameerut.procure247.com/tenderPay/x-login</a> [https://mdameerut.procure247.com/TenderPay/x-login] in prescribed Bank Accounts in favor of "VC MEDA E-Tendering" (As shown in tender document).

## 2. It is mandatory to have 05 years of experience related to the work, otherwise the tender will not be considered.

- 3. The tender shall be in single Bid or two Bid system, as per the cost of work and in case of two Bid system where techno-commercial details such as experience certificates, qualification document etc, Are required then each document must be self attested with Stamp shall be self verified first. For two bid system the Bidders who do not qualify the pre-qualification requirements shall be summarily rejected and their price Bids would become inaccessible. The price Bid of Bidders who are found eligible in prequalification shall be downloaded through E-Tender procurement system after filling their details on the E-Tender portal.
- 4. B.OQ. Rates are excluding G.S.T. and G.S.T. will be paid extra as applicable
- 5. Bidder has to deposit performance Guarantee/additional Security in shape of FOR/CDR/Bank Guarantee/NSC in case rate quoted is more than 10% below from the justitled amount (at the date of tendering), 020.5% per one percent up to 10% below rate and (@1% per one percent on rate quoted beyond 10% below rate, valid for the complete contract period by the Bidder before entering into contract bond.
- 6. Any Information regarding addition/ alteration/ cancellation in E-tendering shall be intimated on MEDA website and UPLC website https://etender.up.nic.in.
- 7. The Tender Notice shall be available on website of Meerut Development Authority at www.mdameerut.org and Tender Documents can be downloaded from UP Electronics Corporation website https://etender.up.nic.in. Interested bidders are requested to visit the websites regularly and update themselves with regard to any change or additional information related to the tender.
- 8. In case of holiday/holidays the E-tender will be opened on next working day.
- 9. There will be no obligation for registered/unregistered agencies.
- 10. Valid Net-worth certificate according to tender amount as per last audited balance sheet and valid character & haisiyat certificates issued by District Magistrate and Other documents as mentioned in E-tender documents is mandatory and should be uploaded with E-tender.
- 11. Affidavit form T-6 duly attested by Notary on Rs. 100/- Stamp required to be uploaded with E-tender.
- 12. All works having value of Rs. 25,00 Lacs & above would be in two bid system only.
- 13. Details of tender fee and EMD must be filled on prescribed proforma (Appendix-E). In case of incorrectly filled tender, They are likely to be rejected and not considered.
- 14. All right are reserved with Vice Chairman, Meerut Development Authority who can reject any or all tenders without assigning any reason.
- 15.BOQ for necessary work. If approved, 10 percent earnest money will have to be deposited before the work order is issued.
- 16.All the material used for maintenance works will be PAP marked/branded. If substandard material is found after investigation, the tender will be canceled and the earnest money will be confiscated.
- 17.It will be mandatory to complete the work within the prescribed time limit mentioned in the work order.
- 18. The entire responsibility for the safety of the workers will be of the concerned contractor.
- 19. Uttar Pradesh Building and Other Construction Workers Welfare Board has made arrangements for labor registration, establishment registration and online application/registration for availing the benefits of the scheme by the beneficiary workers. Therefore, in case the work is allotted, work order is issued and construction work is done. Before starting, it will be mandatory to register with the Labor Department under the Building and Other Construction Workers (Regulation of Employment and Service Conditions) Act, 1996 in relation to the work allotted by the concerned agency.
